Surat. Surat Mahanagar Palika is among the top ten cities for Service Tax deposited in the last Financial Year. Having deposited Rs. 4.50 crore, MANPA was ranked eighth. MANPA is not behind builders and security service providers.

Among the top ten for the Financial Year 2015 – 2016, Magdalla Port ranked 1st by depositing Rs. 19 crore. Saurashtra Enviro Project with Rs. 16 crore ranked 2nd, Colourtex Industries was 3rd with Rs. 11 crore, Vishal Enterprise with approx Rs. 6 crore was 4th, Happy Home Corporation with approx Rs. 5.5 crore was 5th, N.N. Corporation with approx Rs. 5 crore was 6th, Gujarat Maritime Board with approx Rs.4.66 crore was 7th, Surat Mahanagar Palika ranked 8th with approx Rs. 4.50 crore, Shiva Security Agency was 9th at approx Rs. 4.39 crore and Garden Silk Mills with approx Rs. 3.77 crore ranked 10th. Surat is known as the finance capital of India. With rapid growth rate of the city, collection of Service Tax has also gone up.
